# CHARTER TOWNSHIP OF MONITOR REGULAR TOWNSHIP BOARD MEETING MARCH 09, 2015

### 2 Mile Waterline Extension

R. Wieland, Woodhaven development stated he ran into a problem with the site. It was discovered the area on Two Mile from Alpine Village north to Wheeler is in a flood plain. Working with the township to extend the sewer for future development is now moot. Woodhaven will revise their site plan to revert to the original sewer connection planned at the entrance to Alpine Village, through an easement. The township will be included on the easement documents.

Motion by Arnold supported by Pike to discontinue negotiations with Woodhaven developers to extend the sewer line down Two Mile Rd. from Alpine Village to Wheeler Rd. due to information the area is in a flood plain.

#### Park Improvement Plan

The board discussed the park improvement master plan submitted by Spicer. There was discussion regarding implementing the improvements over time and prioritizing those items which are most needed or would increase the townships chances to obtain grants.

### Road Millage Project

The Supervisor gave an update regarding the meetings he has scheduled with the subdivisions on the proposed road millage project plan.

No changes to the proposed plan were offered at this time.

Motion by Miller supported by Arnold to accept, and authorize the Supervisor to sign, the proposal submitted by Bendzinski & Co. to serve as the townships municipal advisor for the issuance of bonds for the road millage project for the fee of \$26,125 based on a bond issue in the amount not-to-exceed \$8,245,000.
